#### **IOCB interdisciplinary grants**



- Established to support opportunities for interdisciplinary collaborations at IOCB
- Complementary to GSRC-3, same format
- 7 applications received by the November 30, 2016 deadline.
- Meeting of the evaluation commission December 22, 2016 (Moravcová, Obšil, Svoboda, Hostomský)
- 2 additional anonymous evaluations secured

#### **IOCB interdisciplinary grants**



- A general comment from an external reviewer:
- …"I am not sure a call for interdisciplinary collaborations associated with grant support is the right approach. Above all, I would emphasize strong projects (not necessarily with medicinal applications) that address important questions and problems. The rest is secondary. If such projects require interdisciplinary collaboration that would make them stronger, great. But if they are competitive without collaboration, that should be sufficient too. Rather than motivate IOCB researchers to form pragmatic alliances to paste something together just to meet the requirements to get some extra cash..."

#### **The Evaluation Committee Report**



- None of the projects was competitive enough to receive full funding. All proposals had caveats, especially in biology, raising questions about feasibility, focus and cost.
- Refine future call rules to emphasize quality and uniqueness, with interdisciplinarity as bonus point.
- Award 500 000 CZK to 3 highest ranked projects until the next call to give them a chance to get preliminary data and perform key proof-of-concept experiments to strenghten the proposals.



The three highest ranking proposals selected for partial funding to strengthen the proposals are:

- Yushchenko/Bouř/Cígler Uncovering the mechanisms of cytotoxicity induced by amyloidogenic proteins
- Jiráček/Hobza/Jahn Development of insulin mimetics
- Lazar/Řezáčová/Jungwirth Fluorescent protein bolts
