If these are known in the moment of the submission, their CV's have to be added to the project proposal as an attachment. Professional collaborator may only be a researcher involved in basic research, whose age does not exceed 35 years in the year of project proposal submission. Collaborator has to be an employee of the organization or has to be employed after the aid was allocated. the subsidy provided to cover commitments from the agreement on work performed outside of employment may not exceed 400 CZK per hour Transfer between items of the basic structure up to 40,000 CZK One person cannot act as investigator in two or more junior projects at the same time Should an applicant of a junior project take part in an EXPRO project as an applicant or co-applicant in a given calendar year, he/she is than not allowed to take part in both of them, instead he/she has to choose between carrying out only one of them in one of these roles.
