Conditions / Restrictions	The tender documentation is only available in Czech. The proposal for a joint research project has to be prepared simultaneously by the Czech research team (based on <u>MEYS call</u> <u>conditions</u> ) and the Austrian investigators (based on <u>BMBWF call</u> <u>conditions</u> ). The Czech and Austrian parts of the project must be identical in terms of content and themes. Several Czech research institutions can participate, however only one main proposer has to be designated on the Czech side of joint research project. The proposal has to be <b>submitted only via data box</b> (datová schránka) <b>vidaawt</b> .
