Applicant must have lived outside Germany for a minimum of 12 months in total in the 18-month period prior to the submission deadline. Good knowledge of English or German. Support of the German host institution, evidenced by a detailed expert's report from the academic host as well as the host's agreement and the confirmation from the administration at the host institution. It is responsibility of PI to check that two referees and host institution have received the request and complete the form and send the form directly to the foundation.
