Call info	Program aims to support development of collaboration of the CAS institutes with research institutions in Germany.
Conditions / Restrictions	Project proposals must be submitted in parallel to both partner organizations. CZ project proposal must be submitted via the KIS application – please fill in the IOCB-KIS internal template and contact the IOCB Project Office. All Czech team members must be employees of the CAS. The research team members are divided into two categories: Category 1(researchers, university teachers, postdocs) and category (2: PhD students, graduates - BA/MA). Maximum exchange quota per research team and calendar year is not assigned. Maximum length of one visit is up to 30 days for category 1 and up to 50 days for category 2. Living expenses of Czech team in Germany will be covered by the DAAD:

	<p>for category 1: 89 EUR/day/person (1st – 22nd day); or 2.000 EUR/month/person (23rd – 30th day);</p> <p>for category 2: 54 EUR/day/person (1st – 20th day), 40EUR/day/person (31st – 50th day); or EUR 1.200 EUR/month/person (21st -30th day). The German research team will receive max 7 500 EUR /year; 15 000 EUR/project.</p> <p>International transportation and travel insurance will not be covered by the CAS.</p> <p>Days not used during one calendar year cannot be transferred to subsequent years of the project.</p> <p>At least 1/3 of all team members must be junior researchers or PhD students.</p> <p>PI can submit more than 1 project proposal, but only 1 project can be funded.</p> <p>Only 2 subsequent projects realized by the same research teams can be funded.</p>
