Conditions / Restrictions	<ul style="list-style-type: none"> GACR LA SNSF supports the projects in basic research with clear aspect of cooperation between Czech and Swiss research team. Proposals will be evaluated under the Lead Agency proces. In particular, the proposals for 2020 call will be evaluated only by the Swiss agency. A project proposal must be prepared according to formal conditions and requirements of the Lead Agency (SNSF). The Lead Agency will ensure the whole evaluation proces in accordance to its usual procedures. Budget proposal is submitted separately for both teams to the national agency in accordance with the national conditions. Each provider funds own national research team.

	<ul style="list-style-type: none"> • A principal investigator or co-investigator cannot submit more than one proposal to the particular call. A principal investigator or co-investigator can take part in other GAČR calls for standards and bilateral project but cannot submit more than one proposal as a principal investigator and one proposal as a co-investigator. • Recommended workload is at least 0,2 full-time equivalent (FTE) for principal investigator and 0,1 FTE for co-investigator. A sum of workloads for one person in all projects financed from GAČR cannot exceed 1 FTE. • The costs of bonuses are not eligible for reimbursement. • If the project proposal comprises a supply worth 500K CZK or more from one supplier (in sum for the whole project duration), it is necessary to attach the offer from the properly identified supplier with particular description of supply and preliminary price. The offer also has to comprise a duly justified calculation of the preliminary price as a whole and for each single supply.
