Call info	Program aims to support development of collaboration of the CAS institutes with research institutions in India.
Conditions / Restrictions	Project proposals must be submitted in parallel to both partner organizations. CZ project proposal must be submitted via the KIS application. You must register in the KIS application using the following <a href="#">link</a> and fill in a project proposal. After finishing your proposal, you shall forward it through your KIS account to the IOCB Director for its approval. The Director shall approve and submit your proposal via his KIS account. All Czech team members must be employees of the CAS. <b>At least 1/3 of all team members must be junior researchers or PhD students.</b>

	<p>The ratio between mobility (min 50%) and research (min 30%) costs shall be maintain on the project level as well as yearly.</p> <p>Transferring financial contributions between these two categories is allowed if the minimal ratio for both categories is maintained.</p> <p>The course of project implementation will be monitored through annual and final reports including use of financial means and justification of costs and transfers between categories.</p> <p>PI can submit more than 1 project proposal, but only 1 project can be funded.</p> <p>Only 2 subsequent projects realized by the same research teams can be funded.</p> <p>Please be aware that due to the situation caused by COVID-19 pandemic, the date of the call and of the deadline for project submission might differ on the CSIR SIDE.</p>

Evaluation criteria	<p>Two-step evaluation: national level &amp; international level</p> <ol style="list-style-type: none"> <li>1) Quality of the project: scientific relevance, concept, innovative character, methodology, work plan of activities and outputs, impact of project results and their dissemination</li> <li>2) Quality of research teams: composition and expertise of research teams, complementarity, methodology, equipment, previous cooperation and outputs, justification of collaboration needs</li> <li>3) Active involvement of junior researchers and PhD students</li> <li>4) Added value and broader impact of bilateral cooperation</li> </ol>
