Blanket salary increase

- Effective April 1, 2022
- Pay raise = average monthly gross salary in Prague for 4Q2021
 * annual inflation rate for 2021 (approx. CZK 2,800 / month / gross)
- Full compensation to "VEJ" : approx. CZK 2,800 * FTE

COVID-19: testing of employees as of Nov. 29



Dear colleagues, in accordance with Emergency Measure from November 19, 2021, effective Monday, November 29 we are obliged to test those employees who are not fully vaccinated against COVID-19, or who have not had Covid in the last 180 days, or who do not provide a test from a sampling point no older than 7 days.

Testing of employees who were registered for testing by their group leader will take place <u>every Monday from 8:00 to 9:00 am, room</u> <u>A.1.50 via Flowflex rapid antigen tests</u>. Testing will be supervised by Dr. Kohoutová's nurse, Mrs. Adéla Blažková. If anyone will not be able to undergo the test on Monday morning, he/she will be obliged to present a negative test from an external sampling point before he/she enters the institute. **Christmas Party**
