Call info	The FEBS Excellence Award supports early career group leaders by providing them with funds over a three-year period to purchase equipment and/or consumables to fund their research project.
Conditions / Restrictions	Applicants should have received their PhD within the past six years (duly justified career breaks, such as ill health, parental leave or compulsory national service may be taken into account).

	<p>Applicants must be employed in a salaried capacity as a group leader at the Host Institution for at least one year prior to the application submission date and must have secured future financial support for the entire 3 year duration of the Award.</p> <p>Host Institutions must be established in a country with a FEBS constituent society (https://www.febs.org/our-members/).</p> <p>Applicants must have a current membership of a FEBS Constituent Society.</p> <p>FEBS Excellence Awards are not granted to scientists who have been recipients of a FEBS Long-Term Fellowship preceding their current employment if the Host Institution is the same.</p> <p>In each call, no more than one candidate per given Host Institution will be granted an Excellence Award.</p> <p>The €100,000 of the FEBS Excellence Award is paid by FEBS to the Host Institution in three instalments over three years.</p> <p>The FEBS Excellence Award should be acknowledged in any work published relating to the project funded and a PDF or doi of each article should be sent electronically to the Chairperson of the Fellowships Committee.</p> <p>By acceptance of a FEBS Excellence Award, Awardees are expected to attend one FEBS Fellows Meeting preceding the annual FEBS Congress, upon invitation from the FEBS Fellowships Chairperson.</p> <p>Past and current holders of an Excellence Award may not apply for another Excellence Award.</p>
Proposal consists of	<p>Application should be submitted through the web-based application (https://fellowships.febs.org/ea_2022) and contain the following information and documents (in English):</p> <ol style="list-style-type: none"> 1) Personal information and information on academic/research activities, entered online (Applicant) 2) Project proposal (max 10 A4-sized pages of single-spaced text, font no smaller than 10pt Times New Roman, minimum top and bottom margins are 2 cm and 2.5 cm, uploaded in PDF format, maximum file size 1 MB), outline of the proposed investigation set out under the following headings: <ol style="list-style-type: none"> i. title; ii. purpose, including the immediate and longer-term aims; iii. background relating the proposed research to the present body of knowledge; iv. plan, including details of the experiments to be carried out; v. motivation for choosing the host laboratory/department/institute, including how it fits longer-term career goals; vi. list of five most significant papers of the host laboratory/department/institute from the last five years; vii. list of the most significant papers of the applicant; viii. detailed description of the planned expenditures (i.e. equipment and consumables); <p>Note: additionally, a timetable (portrait orientation) of the experimental work to be carried out is to be set out on an extra page (not included in the ten-page maximum). (Applicant)</p> 3) Host Institution statement establishing that the applicant is employed in a salaried capacity and the duration of the contract with the Host Institution (Project Office) 4) Letter of support from the host laboratory/department/institute head, written on headed paper, confirming current role of the applicant and facilities applicant has access to, indicating dates the applicant has already spent at the host laboratory/department/institute (on official template; Project Office) 5) Referee's letter of support from someone who has known the applicant for at least two years and is not based at the Host Institution. The referee will be provided with a link for direct upload of their letter and it is the applicant's responsibility to ensure that they do it in time (Referee) 6) Letter of agreement to be signed by both the applicant and the appointed head(s) of the institution in which the proposed work will be carried out. (Applicant & Project Office) 7) FEBS Constituent Society membership letter, dated letter from the appropriate FEBS Constituent Society, confirming that the applicant is a member and indicating the date on which the applicant joined the Society (Applicant)
Evaluation criteria	Applications will be assessed by the FEBS Fellowships Committee and the decisions will be communicated to the applicants no later than December 1st of the same year.
