Information  Conditions /	The goal of the POSTDOC INDIVIDUAL FELLOWSHIP group of projects is to motivate excellent Czech scientists who have long-term international experience, and are in the early stages of their careers, to carry out their own "Excellence Project" at an institution in the Czech Republic for the duration of the Project, i.e. 3 years; to facilitate the transfer of exceptionally talented postdocs from other countries to Czech research organizations, and/or the return of highly talented Czech scientists back to the Czech Republic after completing their scientific missions abroad.  • A single person may only submit as an applicant one POSTDOC INDIVIDUAL
Restrictions	FELLOWSHIP project proposal, or only one JUNIOR STAR project proposal, or an EXPRO project either as an applicant or as a co-applicant.
