Part B – finances and justification

- new: this part must be in English
- cap for the monthly salary remains at 60 000 CZK

Part C1 - project proposal

- new: need to address Gender/Sex dimension in research (this does not refer to gender composition of the team), where relevant for the project solution
- new: a <u>more detailed</u> Data Management Plan is required (description of data that will be collected and how it will be handled), there is emphasis on Open Access
- clarification on the nature and extent of international collaboration planned within the project
- new: brief description of the potential benefits of the project and possible future application potential
- new: need for a brief plan on how the project results will be communicated to its potential users and the public

Part C2 – project results

emphasis on the quality (rather than quantity) of results

Part D2 (other achieved results)

- there is no longer a need to list the total number of results over the last 5 calendar years
- five most significant results **limited to the last 10 years** (previously for the entire career)
- new: include the number of current and past postdoctoral researchers supervised (previously just PhD and MSc/Bc students supervised) and details on university teaching

Part E – information about other projects

new: this part must be in English.

Just a reminder:

The condition still stands that one person can only apply to a limited number of projects across all GAČR calls in a given year – 1x as an Applicant and 1x as a Co-Applicant – includes Standard projects and international ones (bilateral and LEAD Agency – if only Czech team, you are always an Applicant).

JUN STAR and PIF proposals are not included in this limit. Tool for verification

Part A – information about the applicant

- new: include the date of **Ph.D**. **defence** monitoring career stage / time spent in research
- new: **primary institution** of the applicant (country, institution) in the last 3 years (or longer if you have had a career break) demonstrates experience from abroad

Part B

• change in the overheads rate: up to 20% of direct non-investments costs (overhead inclusive)

Part C1 – project proposal

- new: **Risk analysis** required (identification, probability, mitigation)
- new: a reference to the Gender Equality Plan required (IOCB has an Equal Opportunities Plan https://www.uochb.cz/en/equal-opportunities, we also recommend that you also include the HR Award https://www.uochb.cz/en/hr-award) condition for continued financing of the project after first year report
- new: a Data Management Plan is required (description of data that will be collected and how it will be handled), there is emphasis on Open Access

Part D2 (other achieved results)

- summary of scientific career over the last 10 years (previously just 5 years) in the format of a
 "track record"
 description of scientific career contribution to the field, most significant results, not just a
 duplication of CV.
- new: for "significant projects" include **start and end date**, as well as provider, grant value, brief description of topic (if not apparent from title)

Part E – information about other projects

• new: limit for **projects to be included extended to last 5 years** (previously just 3 years), must include **start and end date**.
