- 1. Director's information.
 - a) The director and the Board members congratulated Michal Hocek for getting a 5-years-grant OP JAK.
 - b) The Board got information about the intention of founding the IOCB Branch in Boston. A laboratory space in Cambridge, MA has been identified and it is under preparation. The plan will be presented to the IOCB Supervisory Board for approval.
 - c) The director informed about the organizational changes following the evaluations by the International Advisory Board. The changes will be specified under Director's Decrees on the internal website.
 - d) A communication channel between the management, Board and IOCB public will be formed based on the former internal journal The Bond.

- 4. 70th Anniversary of IOCB and the Open House. Pavlína Řezáčová informed about the program. School kids as well as general public are very interested to come to IOCB for lectures and laboratory excursions.
