Conditions / Restrictions	The project PI has to be part of some COST Action on the day of the call announcement (Wed 13 Dec 2023). The project must have been confirmed by the Action chair or by the Action proposer. The project involvement into a COST Action must have been confirmed by MEYS Guidelines in Czech only. The project proposal must be written in Czech. The proposal has to be prepared in the ISIX on-line application system https://isix.msmt.cz/ . The proposal and signature page must be submitted through the data box (datová schránka) vidaawt . Project duration must be at least 20 months. Project duration must not exceed the duration of the relevant COST action.
