The composition of the committees is binding. Any changes must be notified in writing in advance and forwarded to the Director of the Institute for approval via the Economic Department.

The inventory count will start on 2 January 2024 and will be completed on 18 January 2024. On this date, all documents relating to uninvoiced deliveries, re-invoicing and other documents relating to the inventory as at the balance sheet date, as well as inventories of damaged stocks, stocks that do not show basic occupational safety or fire protection aspects, stocks not needed and stocks proposed for disposal will be handed over to the Economic Department.

The correctness of the values stated in the inventory lists shall be certified by the signatures of all materially responsible persons and members of the inventory committee.

After comparing the physical and accounting situation, the claims committee shall discuss the differences and propose to the Director a method of settlement.

Completion of the inventory shall be understood as the entry in the accounts, on the basis of formally and materially correct documents, of the period covered by the inventory.
