Conditions / Restrictions	<p>Project proposals must be submitted in parallel to both partner organizations.</p> <p>CZ project proposal must be submitted via the KIS application: You must register in the KIS application using the following link and fill in a project proposal. After finishing your proposal, you shall forward it through your KIS account to the IOCB Director for its approval. The Director shall approve and submit your proposal via his KIS account and simultaneously final version of the project proposal must be submitted via the CAS data mailbox.</p> <p>All Czech team members must be employees of the CAS.</p> <p>At least 1/3 out of the whole team must be junior researchers (less than 8 years after receiving PhD) or PhD students.</p> <p>Min. 50 % of the requested financial contribution shall be used to cover mobility costs and shall be maintain on the project level as well as yearly.</p> <p>If justified, travel and living expenses, conference fee in a “third” country (if active participation in a conference, directly related to the project) is eligible mobility cost.</p> <p>Eligibility of all costs will be assessed based on specific justification in the project proposal.</p> <p>The course of project implementation will be monitored through annual and final reports including use of financial means and justification of costs and transfers between categories.</p> <p>PI can submit more than 1 project proposal, but only 1 project can be funded.</p> <p>Only 2 subsequent projects realized by the same research teams can be funded.</p> <p>Please be aware that the date of the call and of the deadline for project submission might differ on the Taiwanese side. Czech/Taiwanese principal investigators, therefore, should make sure that their counterpart submits a matching application by the relevant deadline.</p> <p>Applicant submitting a project proposal following a running project with the same team must justify the need for a continuing project and describe outcomes of the running project. This must be stated in the project proposal form in the part “Description of the project”.</p>
Proposal consists of	<p>Mobility Plus Project Proposal form CZ for CAS (CZ applicant)</p> <p>Abstract (en/cz max 1,100 characters incl. spaces), project description (max 10,000 characters in total incl. spaces), research teams description (max 5,000 characters in total incl. spaces), budget description, CVs of Czech and foreign PIs: (max 1 page each) + list of 5 project-publications in the last five years.</p>
Evaluation criteria	<p>Two-step evaluation: national level & international level</p> <p><u>Procedure:</u></p> <ul style="list-style-type: none"> • Both partner organizations formally check submitted mobility project proposals. • The qualitative evaluation is carried out unilaterally, i.e. by the pre-specified Party (hereinafter referred to as “Lead Party”). The Parties take turns in the evaluation each call. • The Lead Party for the call for Mobility Projects 2025-2026 is CAS. • The Lead Party shall evaluate submitted proposals based on its internal rules, prepare a ranking list and send the evaluation to the partner organization to mutually agree on the final results at international level. <p><u>Criteria:</u></p> <p>1) Scientific and formal quality: Quality of project implementation (concept, approach, methodology, time schedule, outcomes); State-of-the-art; Innovation potential and perspective to broaden knowledge; Expected mutual benefits for both research institutes; Potential of project results and its possible outreach.</p> <p>2) Quality of research teams: Justification of collaboration needs; Competence and qualification of research team members; Level of involvement of junior researchers and PhD students; Research teams’ complementarity; Previous cooperation.</p>
