Evaluation results	First stage (0-6 weeks after cutoff date): pre-screening. Approximately, the top 25% of
	the applications are selected for the second round of evaluation.
	Second stage (7-15weeks); Applicants who pass the first round will undergo an online
	interview with an expert in their field (an EMBO member or young investigator). The interview lasts 90 minutes: 30 minutes – Presentation (PhD research and project plan).
	60 minutes – Discussion and questions.
	Third Stage (15–17 weeks) The committee meets and makes the final fellowship
	decisions. Results are announced within one week after the committee meeting.

Earliest date of implementation	Successful applicants in the Spring Selection Round must start their fellowship between July 1st of that year and February 15th of the following year. Successful applicants in the Autumn Selection Round must start their fellowships between January 1st and August 15th of the following year. Due to practical limitations, fellowships can only start on either the 1st or the 15th of each month.

Call info	The EMBO Postdoctoral Fellowships are awarded for a period of up to two years and support post-doctoral research visits to laboratories throughout Europe and the world. International exchange is a key feature in the application process. As an awardee of the grant, you become part of the EMBO Fellows' network.
Conditions / Restrictions	The applicant must hold a PhD degree or equivalent at the start of the fellowship, at the latest. The PhD degree must have been obtained during the two years prior to the application submission. Exceptions to this rule are made for applicants with prolonged career breaks due to parental leave, etc.
	The applicant must have at least one first (or joint first) author research paper accepted for publication or published in an international peer reviewed journal at the time the application is submitted. If the paper is not yet published but currently "accepted", "accepted in principle", "accepted for publication" or in a similar status, the applicant must submit a copy of the editorial letter proving the status of the paper to fellowships@embo.org. Do NOT indicate the journal impact factor. EMBO is a signatory of DORA, https://sfdora.org/
	A first author preprint with public in-depth peer reviews is also sufficient for eligibility, provided that: i) preprint is posted on a recognized community preprint server (e.g. ArXiv, bioRxiv, medRxiv, Zenodo), ii) the peer reviews are publicly available online, iii) peer reviews were verifiably obtained from an independent preprint peer review community service (e.g. "Peer Community In", "eLife", "Review Commons"), iv) the reviews provide in-depth expert analysis of the rigor and validity of the research and its contribution to the field. Informal comments, highlights and reviews posted by individuals are excluded. Do not list, as publications, papers submitted or in preparation, papers not in English or abstracts of conference presentations.
	The application must involve a change of country . Applications to move within the same country are eligible if the applicant has been living or working in that country for a maximum of six months during the 18 months prior to the time the application is submitted. The applicant may apply only to labs where they did not work for more than six months, and they cannot apply to the country where their PhD was awarded. The applicant needs to register for an EMBO online application account. Once login details for the account have been received it is possible to start an application. Figures and tables cannot be included in the application. The applicant may only submit one application , for one project, at one host laboratory in each round of selection. Reapplication is permitted only once, only in case of substantial changes to the proposal and/or the CV of the applicant.
	The applicant should list and activate two referees and the receiving institute contact person as soon as possible, preferably by 4 weeks prior to the deadline. It is the responsibility of the applicant to check that the referees and the receiving institute have received the request and have completed the form. The reference letters and acceptance letter from the receiving institute must use institutional email addresses and not private ones. It is the applicant's responsibility to arrange the interview with the interviewer and to make sure they have all the required documents in order before they travel. The applicant may be asked to give a seminar as part of the interview procedure. Applicants who wish to work in a Non-EMBC Member State must move from an EMBC Member State, must be nationals of an EMBC Member State, must have performed their PhD in one of the EMBC Member States.
	Starting with the Spring 2020 Call, EMBO will offer funds in EMBC member states for host institutions to issue employment contracts to awardees. Fellows outside EMBC member states will receive a stipend as before.

	collaborated in the past generally receive lower priority for funding. Projects that are a

	Fellowships are awarded to candidates, but evaluation also takes into account the host
	laboratory suitability: significant changes to the project or move to a different laboratory
	would thus result in the termination of the fellowship.
