	simultaneously final version of the project proposal must be submitted via the CAS data mailbox
	All Czech team members must be employees of the CAS.
	At least 1/3 out of the whole team must be junior researchers (less than 8 years after
	receiving PhD) or PhD students.
	Min. 50 % of the requested financial contribution shall be used to cover mobility costs and
	shall be maintain on the project level as well as yearly.
	If justified, travel and living expenses, conference fee in a "third" country (if active participation in
	a conference, directly related to the project) is eligible mobility cost.
	Eligibility of all costs will be assessed based on specific justification in the project proposal.
	The course of project implementation will be monitored through annual and final reports
	including use of financial means and justification of costs and transfers between categories.
	PI can submit more than 1 project proposal, but only 1 project can be funded.
